Section 2 - Hazards Identification

Statement of Hazardous Nature

This product is classified as: Xn, Harmful. Hazardous according to the criteria of SWA.

Not subject to the ADG Code when transported in Australia by Road or Rail in packages 500kg(L) or less; or IBCs (refer to SP AU01). However if transported by Air or Sea, this provision does not apply. Then the product is classed as Dangerous (Class 9 Environmentally Hazardous) by IATA and IMDG/IMSBC respectively. Emergency Overview

Physical Description & Colour: Off white, gritty powder

Odour: Weak Characteristic odour.

Major Health Hazards: Prochloraz has low acute toxicity. The LD₅₀ in rats treated orally was 1600–2400 mg/kg bw, and the main toxic effects were reversible central nervous system depression and gastrointestinal irritation. WHO (1999) has classified prochloraz as 'slightly hazardous'. The LD₅₀ after dermal application was > 2100 mg/kg bw in rats and > 3000 mg/kg bw in rabbits, and the LC₅₀ in rats exposed by inhalation for 4 h was > 2.2 mg/l of air, the highest achievable concentration. The compound was not irritating to the skin of rabbits after a 4 hour exposure, was not irritating to the eyes of rabbits and did not sensitize the guinea-pig skin in a Magnusson and Kligman maximization test. Harmful if swallowed.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

Inhalation: First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

Skin Contact: Quickly and gently brush away excess particles. Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 10 minutes or until chemical is removed. If irritation persists, repeat flushing and obtain medical advice.

Eye Contact: Quickly and gently brush particles from eyes. Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed, while holding the eyelid(s) open. Obtain medical advice immediately if irritation occurs. Take special care if exposed person is wearing contact lenses.

Ingestion: If swallowed, do NOT induce vomiting. Wash mouth with water and contact a Poisons Information Centre, or call a doctor.

Section 5 - Fire Fighting Measures

Fire and Explosion Hazards: The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is little risk of an explosion from this product if commercial quantities are involved in a fire.

Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

Section 6 - Accidental Release Measures

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Evacuate the spill area and deny entry to unnecessary and unprotected personnel. Wear full protective clothing including eye/face protection. All skin areas should be covered. See below under Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include cotton overalls with PVC or nitrile gloves. Eye/face protective equipment should comprise as a minimum, protective goggles. If there is a significant chance that dusts are likely to build up in cleanup area, we recommend that you use a suitable dust mask.

Stop leak if safe to do so, and contain spill. Because of the environmentally hazardous nature of this product, special care should be taken to restrict release to waterways or drains. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Consider vacuuming if appropriate. Recycle containers wherever possible after careful cleaning. Refer to product label for specific instructions. After spills, wash area preventing runoff from entering drains. Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. The ADI for Prochloraz is set at 0.01mg/kg/day. The corresponding NOEL is set at 1mg/kg/day. ADI means Acceptable Daily Intake; NOEL means No-observable-effect-level. Data from Australian ADI List, June 2014.

No special equipment is usually needed when occasionally handling small quantities. The following instructions are for bulk handling or where regular exposure in an occupational setting occurs without proper containment systems.

Section 10 - Stability and Reactivity

Reactivity: This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

Conditions to Avoid: This product should be kept in a cool place, preferably below 30°C. Keep containers tightly closed. Containers should be kept dry. Keep containers and surrounding areas well ventilated. Protect this product from light. Store in the closed original container in a dry, cool, well-ventilated area out of direct sunlight.

Incompatibilities: Extreme heat.

Fire Decomposition: Combustion forms carbon dioxide, and if incomplete, carbon monoxide and possibly smoke. Water is also formed. May form nitrogen and its compounds, and under some circumstances, oxides of nitrogen. Occasionally hydrogen cyanide gas in reducing atmospheres. May form hydrogen chloride gas, other compounds of chlorine. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

Polymerisation: Polymerisation reactions are unlikely; they are not expected to occur.

Section 11 - Toxicological Information

Toxicity: No carcinogenic effect was observed in rats. In the study in mice, an increased incidence of liver adenomas and carcinomas was found in both males and females at concentrations above 325 ppm.

A comprehensive range of studies of genotoxicity gave consistently negative results, except for a weakly positive response in a test for sister chromatid exchange in Chinese hamster ovary cells in vitro in both the presence and the absence of an exogenous metabolic activation system.

In a two-generation study of reproductive toxicity in rats, reproductive performance was affected only at a concentration harmful to the mother. There is no data to hand indicating any particular target organs.
